Example of bonus calculation.

Clients deposit directly to account type Frux Standard and receive the bonus accordingly.

• Deposit amount in balance: 100 USD

• Bonus received in credit: 20 USD (remaining 80 USD)

• Total Equity: 120 USD

The client trades and makes a profit of 100 USD from an equity of 120 USD. The client wishes to request a withdrawal.

Balance: 200 USDCredit: 20 USDEquity: 220 USD

After the withdrawal of 200 USD, the bonus will be reset to 0 USD. The trading account can be used for subsequent deposits until the maximum bonus of 100 USD is claimed.
